## Supplemental information

The reproductive toxicity associated with this product is expected to occur via the ingestion route only.

Hydrogen fluoride, a possible decomposition product, is extremely corrosive and a poison by all routes of entry. Hydrogen fluoride can penetrate the skin and produce burns, which may not be immediately painful or visible; the burns impact the lower layers of skin and bone tissue. Hydrogen fluoride exposures involving 20 percent of the body or more can be fatal through systemic fluoride poisoning.

## 4. First-aid measures

**Inhalation** Remove person from contaminated area to fresh air. Apply artificial respiration if needed.

**Skin contact** Remove contaminated clothes and rinse skin thoroughly with water for at least 15 minutes. A 2.5 pct calcium gluconate gel applied topically after skin has been thoroughly washed will help reduce severity of symptoms.

**Eye contact** Immediately rinse eyes with water. Remove any contact lenses, and continue flushing eyes with running water for at least 15 minutes. Hold eyelids apart to ensure rinsing of the entire surface of the eye and lids with water. Get immediate medical attention.

**Ingestion** Do NOT induce vomiting. Immediately rinse mouth and drink a cupful of water. Never give anything by mouth to an unconscious person. Get medical attention immediately. If vomiting occurs, keep head low so that stomach content doesn't get into the lungs.

## 5. Fire-fighting measures

## 6. Accidental release measures
